Bruce and Russ presented a list of suggested trail etiquette for Canby's Logging Road Trail. Committee relayed concerns around off-leash dogs, pedestrians blocking trail, excessive speeds. List to be used on Logging Road Trail Facebook Page. Facebook pages has many 'likes' and needs more content.

Oregon Bicyclists Manual from ODOT is available and we can order printed materials from ODOT. BPAC will begin with sharing digital resources and investigate hardcopy resources further before having Calvin order paper products needlessly.

Calvin provided Councilor Parkers update: URA refinanced debt, saves \$5 million. Staff assembled projects list. One idea that seems to have support from URA Commissioners is 2 pathways from the logging road bridge down to Fred Meyer/ sidewalk. Public Works estimates these improvements can be done "in house" for \$200,000 each. Discussion around promoting this idea and advocating for these improvements.

Mindy thanked the BPAC for participating in Molalla River Watch SOLVE cleanup in the recreation corridor. MRW was appreciative and Canby BPAC made up ¼ of attendees.

Calvin Thanked the BPAC volunteers who attended a photoshoot with the Willamette Valley Visitors Association on April 10. The photos will be used for Canby's promotional efforts including a brochure which will be published this summer.

Bruce describe a Clackamas County program to use bike counters on roadways/ pathways. Bruce is advocating the County to include more rural parts of the County, as the plan focuses more on the more populous areas around Milwaukie and Gladstone. Discussion of County roads in Canby such as S Ivy, Territorial, etc. Mindy suggested a counter on Holly between Flower Farms and Territorial to reflect agricultural commuter traffic.

Britt provided an outreach update – urged BPAC to continue posting photos or any other content to Logging Road Trail Facebook page. Will work with Lupita to post English and Spanish version of the Oregon Bicycle Manual to the page.
