## **New Business:**

 Upcoming Grant Opportunities: Oregon Community Paths Grants, Federal EDA Grants - Mindy said Allan Thompson is the resource for grants application. Jamie said she would be sending out information on the SDA grants.

#### **Old Business:**

- Parks and Rec Update Greg said based on the public responses received; the priorities are #1
  Trails and Paths, #2 Dog Park and #3 Taking Care of Existing Parks. Mindy said the OR Soccer
  Assn wants 40 acres in Canby Area for a soccer complex.
- Sidewalks: Transit Stop Bus Shelters Greg said ODOT Paving of 99E includes building 11 bus shelters. Also, Russ thought filling sidewalk gaps should be a first priority. Greg said the county didn't require sidewalks with new developments, which were later brought into the city. He thinks the city should just go ahead and pay for the sidewalks.
- Staff Update: Jamie has hired a Tourism Coordinator.
- Revised Trail Etiquette Final Draft Placement of signs was discussed. Bruce said the wording should be concise. Any sign requests should be sent to Jerry Nelzine.
- Brief Update Clack County Bike Ped Bruce said their first priority is to fix the gap in the I-205 bike path. Second priority is the proposed Or City/West Linn bike bridge.
- SRTS: Cliff said the grant criteria have changed. Development within two mile perimeter of the schools can be included. Mindy said committee members should visit Baker Prairie and Troost in March or April and observe students walking to and from school.
- MFR Jamie said that Dan Miller of NPS thought we should set a date to send out post cards to stakeholders, including adjacent property owners for a meeting. The Meeting could be held on April 12 in place of our regular meeting. Top city leaders should attend including the City Administrator and City Attorney.
- City Council Greg said that the council is having a goal setting session Friday. His priorities are the continuation of the park maintenance fee and the street fee.
