# **Background**

# American Recovery Plan Act (ARPA)

The American Rescue Plan Act (ARPA) of 2021 (H.R. 1319) was signed into law on March 11, 2021. This \$1.9 trillion federal bill was passed to support recovery efforts in response to the ongoing COVID-19 pandemic. Of this total funding package, \$362 billion was provided to help states, territories, counties, cities and tribal governments cover increased expenditures, replenish lost revenue, and to mitigate economic impacts from the COVID-19 pandemic.

All Cities receive direct funding allocations through this legislation. Canby's total allocation is estimated to be \$3.98 million. Canby's first of two installments of \$1.99 million was received in August 2021. The second installment of \$1.99 million is expected to arrive no earlier than May 2022. Two key timelines/deadlines for use of these funds:

December 2024 – All funds must be obligated (allocated/committed).

December 2026 – All funding and projects concluded must be spent.

Staff will provide a summary on the U.S. Treasury's Interim Final Rules on the ARPA funding, and will seek Council feedback for use of the City of Canby's funding allocation.

# Housing and Economic Opportunity Analysis Advisory Committees – Council Representatives

The City of Canby Planning Department secured a \$100,000 grant from the State of Oregon Department of Land Conservation and Development (DLCD) for a Housing Inventory Assessment. Similarly, the City secured a \$50,000 grant from DLCD for an Economic Opportunity Analysis. We will be procuring the services of consultants to assist us with these important planning processes. Staff is requesting two Council representatives — one for each committee - to participate in two advisory committees related to the (1) Housing Needs Assessment/Housing Production Strategy and (2) the Economic Opportunity Analysis. Both of these processes are anticipated to begin in January. Following is a brief summary about each of the two committees:

Housing Advisory Committee:

12 month duration

Up to 7 advisory committee meetings

Advising on housing, type, affordability, and urban growth expansion to accommodate 20 –year of forecasted growth.

**Economic Advisory Committee:** 

14 month duration

Up to 3 advisory committee meetings

Advising on need for employment lands, type of employment and urban growth expansion to accommodate employment needs over next 20-years.

# **City Council Goal Setting Retreat**

Information and options will be for consideration of holding a facilitated goal setting retreat in early 2022.
