The first red flag was when Judy notified me that without explanation the first set of interviews earlier in the month had been canceled only 30 minutes prior to When they were schedule

At the time there were three candidates for three positions. Dan, Judy, and Chris

I chatted with Shaun about the reason for the cancellation and his only explanation was, it's being handled.

Then a week later and two days after the deadline, two plumbers who work for the same company applied and put on their form that they were referred by Shaun. I am open to an innocent explanation but on the surface it appears that he canceled the interviews in order to go out and recruit two people to replace the two people he didn't want.



Then after the interviews, someone presumably Shaun submitted to Melissa altered application forms that are in our agenda packet



It's perception, and this looks shifty.

Both Bangs and I have sent Joe and Scott emails asking them to look into this for us.



And one other thing. Even though the process does not call for the planning Director to be a part of the interview selection, it's traditionally been done. And on the first scheduled interviews, the planning director was going to be part of the process. Then during the second scheduled interviews, he was out of town. Now I guess it could be argued that they didn't want to further delay the process and therefore they proceeded with out the planning Director but there's that

This all seems like a concerted effort to establish a PC that leans heavily one direction.


