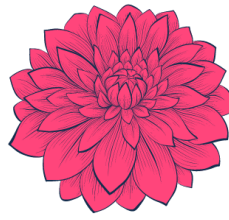

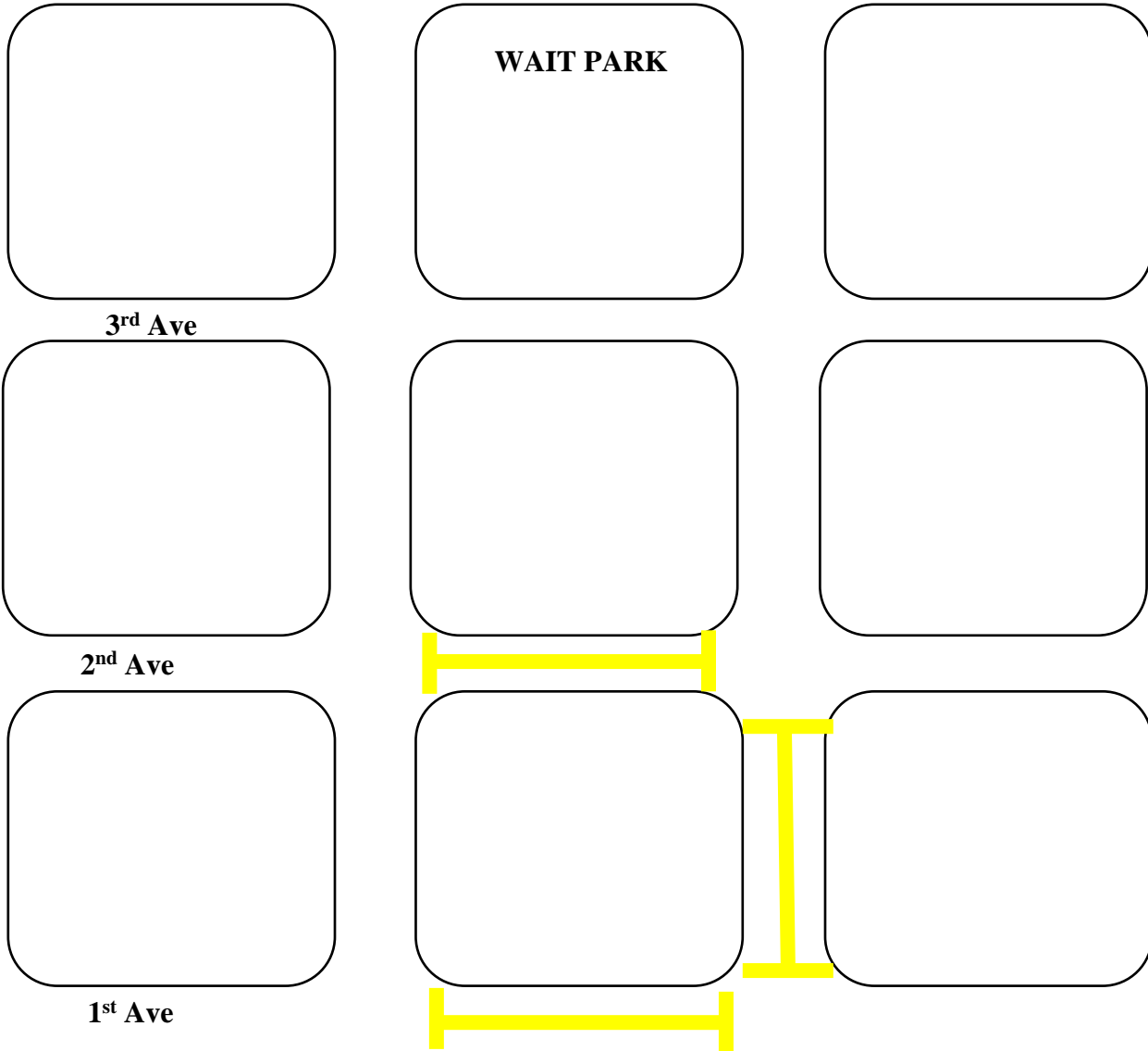

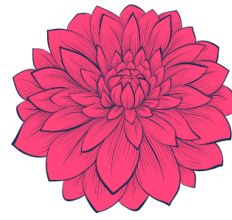

Vendor Waiver and Hold Harmless Agreement

By signing and dating below, the undersigned (“Vendor”) represents and warrants the Vendor has read, understands, and is voluntarily and knowingly agreeing to each of the following:

- _____ 1. Vendor has reviewed and agrees to comply with the First Thursday Night Market, Canby
Initial Business, and City of Canby registration requirements in seeking admission to the First Thursday Night Market.
- _____ 2. Vendor agrees to allow employees, representatives, and agents of the City of Canby and Canby
