RESOLUTION APPROVING PARTICIPATION BY LOCAL HOUSING OWNERS
IN THE FEDERAL RENT SUPPLEMENT PROGRAM.

WHEREAS, under the provisions of Section 101 of the Housing and Urban Development Act of 1965, the Secretary of Housing and Urban Development is authorized to enter into contracts to make rent supplement payments to certain qualified housing owners on behalf of qualified low-income families who are elderly, handicapped, displaced, victims of natural disaster or occupants of substandard housing; and

WHEREAS, the provisions of said Section 101 cannot be made available to housing owners in certain localities unless the governing body of the locality has by Resolution given approval for such participation in the Federal Rent Supplement Program.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Canby, Clackamas County, State of Oregon, as follows:

Approval is hereby granted for participation in the Federal Rent Supplement Program by qualified housing owners of property located in Canby, Clackamas County, State of Oregon.

Adopted by the Canby City Council at a regular meeting this 21st day of September, 1970.

Dear Mayor Housen:

I studied the suggested form of Resolution left by Mr. Miller during the Council meeting on September 8th. The suggested form of the Resolution purports to be one prepared by the Department of Housing and Urban Development, and I have followed the suggested form in preparing proposed Resolution No. CIII for the Council's consideration at its next regular meeting.

Apparently the applicant's request for participation under the Federal Act will depend on the City Council's approval of low-cost housing developments in Canby. I am sure that no one can argue with the merits of the program, but I would recommend that the Council or a committee of the Council investigate carefully the experiences of other Oregon communities which have agreed to participate in this Program. I think that Mr. Miller gave you the names and locations of two or three other localities in Oregon, and there may be others. I am of the opinion that the Portland office of HUD could probably furnish you with additional information if required. I'll be glad to pursue the matter further if you want me to.

I am sending a copy of this letter to Recorder Richardson with six extra copies of the proposed Resolution for distribution to the Councilmen and their study prior to the next meeting.
