# a. Project Meadowlark (DR 24-01) – Ryan Potter, AICP, Planning Manager

The Oregon Liquor and Cannabis Commission (OLCC) requests Planning Commission approval to construct a 347,645-square-foot building in Canby to facilitate relocation of its distribution operations from Milwaukie. The proposed facility would feature approximately 12,221 square feet of office space and 335,424 square feet of warehouse space. A 9.3-acre portion of the subject property not planned for development would be formed into its own lot.

Approval of the proposed project requires Planning Commission approval of Site and Design Review Application DR 24-01, Conditional Use Permit Application CUP 24-01, and Property Line Adjustment Application PLA 24-04.
