PUBLIC HEARINGS -

a. Okada America – Ryan Potter, AICP—Senior Planner

A Site and Design Review/Lot Line Adjustment application for property located 368 & 372 S Sequoia Parkway was scheduled to be heard on this date but the applicant, Okada America, requested the hearing be delayed until a date certain of Monday, January 10, 2022.

Commissioner Padden asked when DKS would come back to a Council/Commission Work Session. Mr. Hardy was working to schedule a date.

Commissioner Padden asked about items that came to the Commission and those that did not and items that could be appealed. Mr. Hardy explained the process for Type I and Type II applications, which did not come to the Commission.

Commissioner Hieb asked about tax exemptions in the industrial area. Mr. Hardy said Jamie Stickel, Economic Development Director, could give more information about that.

There was discussion regarding the upcoming hearing schedule and appointment of new Commissioners.
