Planning Manager Potter introduced the old business to the Commission and the reasoning behind why the Final Findings for this project were brought back as a discussion item. He explained that the language added to Condition of Approval #34 during the project approval's second reading was later deemed inappropriate and stricken from the condition by Planning Staff. This was in part because the additional language, related to street improvements, was not consistent with the City's Public Work standards. Legal Counsel Doughman further explained the legality that is involved in adding language to a condition of approval after a closed hearing. He gave additional advice to the Commission as to how to approach this issue in the future.

Legal Counsel Doughman gave his advice regarding hearing procedural processes and components. He mentioned the Commission should focus on what state law imposes directly onto Commissions. He agreed with the sentiment from Jarosh that Robert's Rules can be counterproductive at times.
