PLANNING COMMISSION WORK SESSION

The Planning Commission met in a Work Session to discuss the following topic:

- **Fence Code Revisions**, presented by Ryan Potter, Planning Manager. Staff led the sixth and final work session related to the City's fence code update. The work session involved a discussion of code language and was intended to prepare City staff for advancing a formal text code amendment to the Planning Commission and City Council.

Staff Presentation: Ryan Potter, AICP, Planning Manager

Ryan Potter, Planning Manager, presented the draft amendments intended to balance privacy, safety, and aesthetics, with an emphasis on clarifying and strengthening vision clearance requirements across all zones and lot configurations. The proposed updates also allow greater flexibility for corner lots and simplify fence standards along paths and within residential, commercial, and industrial zones.

The Commission discussed potential allowances for taller fences in residential areas adjacent to commercial or industrial zones to address buffering, noise, and safety concerns. Additional topics included fence height limits, step-down requirements near front setbacks, screening standards for industrial storage yards, and potential code clean-up items such as removing the arbor section and clarifying definitions.

Commissioners provided feedback and directed staff to refine the draft language in preparation for a formal text amendment, which will return to the Planning Commission for recommendation prior to City Council consideration.

- b. Planning Director's Update

Don Hardy, Planning Director, provided an update on the upcoming Comprehensive Plan and Urban Growth Boundary work. The Planning Commission will be engaged in reviewing policies and goals for City and UGB areas, with work sessions anticipated in the coming months. The comprehensive plan will cover various chapters including land use, natural resources, housing, and transportation. Additional future topics include parks planning, system development charges, and floodplain ordinance updates.

The next few Planning Commission meetings may be canceled due to lack of agenda items but work sessions on the comprehensive plan are planned for June and July of 2026.

Director Hardy will follow up with Commissioner Ellison regarding her term end date and potential continuation. Hardy and Commissioner Lewelling will play to meet to discuss specifics about reviewing and potentially expanding the Pioneer Industrial Park Master Plan.
