Introductions:

Review and Approval of Minutes from June 11, 2021:

- **Discussion of right hand turn only signs at businesses on 99 at major intersections.**
 - Clint suggested a field trip to these locations and invite police, planning and public works.
 - Need to look at all the businesses around these locations.

- **Canby Police Department Report:** None
- **Canby Planning Department Report:** Erik Forsell
 - Application has been submitted for Tofte South. Large sub-division with 120-150 units east of Ivy towards the river. (R1 – single family)
 - Canby Center – significant upgrade for the facility.
 - Ivy Ridge Phase II – making improvements to Ivy. Sidewalks and lights will be installed. There will be a Round – About at 18th and Ivy at some point but they still need to acquire property on one corner.
 - The more the citizens are involved the better.
- **Canby Public Works Department Report:** Spencer Polack
 - Summer paving projects are starting.
 - i. Ivy to back lot of Safeway
 - ii. 13th to Township on S. Redwood
 - iii. N. 2nd Avenue Grant to Holly

 - ii. Turn lane – reduce wait time for the cul d sac
 - Capital Improvement for Locust will go out to bid later this year. (Re-bid in the fall)

- Intersection at Spaceage Gas Station (Berg Parkway / 13th) the arrows at this intersection are very confusing.
