Introductions:

Citizen Input:

- Jennifer Driskill asked if it would be possible to bump the December community meeting out further to allow for more information to be gathered. She is interested in finding out about line of site at the intersections. Would it be possible to paint the curbs at the intersection to prevent parking up to the stop signs? Spencer said that they need good weather before they can paint curbs. He will check to see if safety cones could be placed out there temporarily to prevent parking up to the stop signs. The question was also asked about which side of the street would become the “No Parking” side? And where will the residents place their three garbage cans on Monday mornings? Jennifer sent an email with these questions to Bob. He will now send out to the commission members so they can review.

Old Business:

- **Pending issues**

- I. Enterprise Rent a Car – Bob spoke with Don Hardy in the Planning Department. They sent a letter on September 24, 2021, to Enterprise and did not receive a response. An email was also sent on October 14, 2021, and they have still not had a response. This item will remain on the agenda until this issue is resolved.
- II. S 2nd and S 3rd Street – Bob recapped this issue. The safety aspect of these two streets is an issue. Reducing parking to one side of the street on these two streets would allow for fire apparatus to move down the street as well as other large vehicles. The original plan was to have the community meeting in December and then discuss the recommendations at the January meeting. It was then suggested to put a plan together with three options and then present those options to the community to see which one they would choose. The commission members were polled, and it was decided to postpone the community meeting until the options can be defined. A sub-committee will be formed and go out to the site and walk the area.
