CANBY URBAN RENEWAL AGENCY SPECIAL MEETING MINUTES June 17, 2020

PRESIDING: Chair Tim Dale.

COMMISSIONERS PRESENT: Trygve Berge, Greg Parker, Brian Hodson, and Shawn Varwig, Sarah Spoon.

COMMISSIONERS ABSENT: Traci Hensley.

STAFF PRESENT: Amanda Zeiber, Interim Agency Director, Joseph Lindsay, City Attorney; Julie Blums, Finance Director and Melissa Bisset, City Recorder.

CALL TO ORDER: Chair Dale called the Special Meeting to order at 6:16 p.m. in the Council Chambers.

CITIZEN INPUT: None.

UPDATE ON QUIET ZONE AND GRANT STREET ARCH PROJECTS: Interim Agency Director Zeiber shared that a Request for Proposals went out in February and there was one response. The response was significantly higher than what the engineer's estimates were. The contractor was interested in value engineering the project. The number was reduced from 55 percent higher to 22 percent higher than the engineer's estimate. Ms. Zeiber asked if the project should continue to move forward. There was funding available and there would need to be a supplemental budget to appropriate the funds.

Chair Dale did not want to lose inertia on the Project.

Commissioner Berge felt that they did a good job on value engineering the Project. He was concerned about the Project being split into two projects with two different contractors. He thought that the contractor was trying to be a good partner in the project and had done good work in Canby in the past. He noted that there were many unknown variables in postponing the project. He wanted to move forward with the Project.

Commissioner Parker felt it was more important than ever for citizens to be seeing positive things happening downtown.

The Project would continue to move forward.

CONSENT AGENDA: **Vice Chair Hodson moved to adopt the minutes of the April 15, 2020 Urban Renewal Agency Special Meeting and the reappointments of Michelle Hensley and Jason Padden to the Urban Renewal Agency Budget Committee. Motion was seconded by Commissioner Spoon and passed 6-0.

PUBLIC HEARING

Chair Dale read the public hearing statement and opened the public hearing at 6:33 pm.

He stated that all interested persons in attendance would be heard on the matter. In compliance with Executive Order No. 20-16 related to public meetings during Coronavirus Outbreak - opportunity was given to sign up or provide testimony by 5:00 p.m. the day of the meeting. No request for comment or testimony was received by the City Recorder and no one from the public was present in the Council Chambers.

Finance Director Julie Blums explained that per Budget Law, the Budget Committee convened on May 21st, 2020 and deliberated over the proposed budget and the Committee voted unanimously to approve the proposed budget. She noted that they could adopt the Budget or make changes.

The Public hearing was closed at 6:35 p.m.

Vice Chair Hodson noted that there were several projects continuing to move forward including the Quiet Zone, Façade Improvement Program, and Signalization at Hazel Dell Way and Sequoia. They were on track with debt service payment.

Ms. Blums explained many of the loans would be paid off early creating interest savings.
