## CANBY URBAN RENEWAL AGENCY WORK SESSION MEETING MINUTES March 16, 2022

PRESIDING: Vice Chair Brian Hodson

**COMMISSIONERS PRESENT:** David Bajorin (Virtual), Traci Hensley, Greg Parker, Sarah Spoon, and Christopher Bangs

COMMISSIONERS ABSENT: Chair Varwig

**STAFF PRESENT:** Scott Archer, City Administrator/Agency Director; Joseph Lindsay, City Attorney/Assistant City Administrator; Jamie Stickel, Economic Development Director; Maya Benham, Deputy City Recorder; and Jerry Nelzen, Public Works Director

CALL TO ORDER: Vice Chair Hodson called the Work Session to order at 6:01 p.m.

**CITIZEN INPUT:** <u>Shawn Carroll</u> was representing the Canby Fire District Board of Directors. They urged the Commissioners to limit the number of projects in the future. They would like the Urban Renewal District to sunset in 2025-26 which would help with hiring more Fire District personnel.

CONSENT AGENDA: \*\*Commissioner Hensley moved to adopt the minutes of the February 16, 2022, Urban Renewal Agency Work Session and reappointment of Jack Pendleton to the Urban Renewal Budget Committee for a term expiring on June 30, 2024. Motion was seconded by Commissioner Spoon and passed 5-0-1 with Commissioner Bangs abstaining.

NEW BUSINESS: Discussion Regarding URA Projects -

Jamie Stickel, Economic Development Director, presented the possible Urban Renewal projects that would use the remaining URA Funds. She discussed Urban Renewal refinancing which resulted in approximately \$6 million in savings. She reviewed the URD goals, eligible projects in the current plan, current and continued use of the URA funds, and possible uses of the remaining funds. Those uses included: painting the Logging Trail Bridge over Hwy 99E, installing foot bridge access to the Logging Trail Bridge over Hwy 99E, installing foot bridge access to the Logging Trail Bridge over Hwy 99E, installing foot bridge access to the Logging Trail Bridge at the south side (Fred Meyers), Community Park waterline, bathrooms, and sewer, NW 2<sup>nd</sup> Avenue from Grant Street to Elm Street, 12 downtown alleyways (1<sup>st</sup> Ave – 4<sup>th</sup> Ave, Ivy Street – Cedar Street), 1<sup>st</sup> to 2<sup>nd</sup> on Fir Street and Grant Street, NW 1<sup>st</sup> Avenue from Elm Street to Douglas Street, Township Road from Baker Prairie Middle School to Sequoia, and Wait Park improvements. She then gave preliminary cost estimates and options for the projects. Staff recommended the HWY 99E roadway improvements, HWY 99E gateway improvements, Logging Trail access to Fred Meyer, Community Park upgrades, 2<sup>nd</sup> Avenue upgrades, alleyway improvements, contingency, and project management consultant. These projects would cost a total of \$5,152,000.

Mayor Hodson asked why they were proposing colored concrete on Hwy 99E. Ms. Stickel said it would help slow traffic down. Scott Archer, Agency Director, said the idea was taken directly from the 99E Plan. It would also act as a visual gateway.

Councilor Parker thought they should put the colored concrete at the bottom of the priority.

Commissioner Spoon was not in favor of spending the money on the colored concrete. She suggested considering something else on the south side of town.

Council President Hensley was also not in favor of the colored concrete.

Discussion ensued around staff's recommended list of improvements.

Commissioner Spoon asked about the improvements to the NW 2<sup>nd</sup> Avenue intersections.

Jerry Nelzen, Public Works Director, explained it was currently stamped concrete at those intersections, and they could reconstruct it to match NW 1<sup>st</sup> or they could go with black top and striping.

Commissioner Spoon asked about the improvements to the alleyways. She would like to add lighting to the alleyways for pedestrians. Mr. Nelzen said the project would improve the road surface.

Vice Chair Hodson asked if the funding that had been freed up from the Walnut Street project could be used for the alleyways and intersections.

Mr. Archer said the \$2.9 million going to the Walnut Street project did give them a cushion. There were other potential funding sources to use other than Urban Renewal. Anything that was not spent went back into the Urban Renewal District. They needed to make sure the projects could be completed within the life of the district.

Commissioner Bangs asked about the improvements to Community Park. Mr. Nelzen explained the Boy Scout house was currently on a septic system. They were proposing one unisex restroom with two stalls to replace the existing bathroom.

Vice Chair Hodson suggested setting funds aside to purchase land and/or leverage projects.

Commissioner Spoon thought they should advance the bridge gateway design, pedestrian access, and Community Park projects sooner rather than later. Those three projects amounted to about \$3 million and the rest could be used for land purchase or set aside.

Commissioner Hensley thought the funding should be used on the alleyways, 2<sup>nd</sup> Avenue upgrades, and Community Park. She was not interested in purchasing property.

Commissioner Bajorin thought the gateway improvements, Logging Trail access, and Community Park were highest priority.

March 16, 2022 Urban Renewal Agency Work Session Meeting Minutes Page 2 of 3 URA Packet - Page 2 of 20 Commissioner Parker would like to explore the possibility of purchasing land. He would like staff to find out how much money would buy them how much time off of the URA.

Vice Chair Hodson thought the top priorities should be the gateway improvements, Logging Trail access to Fred Meyer, and Community Park. They should look at other funding options for 2<sup>nd</sup> Avenue and the alleyways.

Commissioner Bangs asked how quickly Community Park could be fixed. Mr. Nelzen said the City had a project ready for bid for a nearby pump station, and they could add onto the bid the sewer and water for Community Park with that project.

Vice Chair Hodson asked about staff's work load and moving forward with the projects.

Mr. Archer said the Community Park upgrades would be the easiest project for staff to proceed with.

There was consensus that Community Park should be top priority, followed by the Gateway improvements, and then the Logging Trail access. There should be fluidity that if there was time and money, they could also work on the 2<sup>nd</sup> Avenue upgrades and alleyway improvements.

Vice Chair Hodson adjourned the Work Session at 7:14 p.m.

## **Summary**

The City of Canby received an application for a Façade Improvement Program grant for the Ace Glass commercial property located at 103 SW 1<sup>st</sup> Avenue for up to \$25,000. The applicant intends to update their façade to improve the property located at the prominent corner of Grant Street and HWY 99E in Canby.

The proposed façade improvement project includes the following:

- Refurbish the building's exterior appearance with painting prep
- Repair CMU block wall
- Repair or replace windows
- Prime and paint exterior

## **Background**

Since 2010, The Canby Urban Renewal Agency has funded construction grants of up to \$25,000 to encourage private investment within Canby's Urban Renewal District. The Façade Improvement Program partners with property owners and businesses to make improvements to the exterior of buildings clearly visible from the street. This partnership helps the Canby Business District revitalize and become more inviting to tenants, customers, and residents. This program has been successful in generating design improvements at approximately 3 properties per year in downtown Canby and along HWY 99E.

#### Discussion

The Ace Glass building is located along HWY 99E on the prominent corner of Grant Street and HWY 99E. The building was damaged in October 2020 when a truck struck the front of the building. The damage was temporarily mended with a piece of plywood, which remains in place at this time. In addition to repairing the damaged facade along HWY 99E, the owner will further upgrade the exterior of the building with new paint and new windows.




## **Recommendation**





## <u>Summary</u>

City of Canby Economic Development staff recently received a Blade Sign Program application for the businesses housed in the Dahlia Apartment building. City staff met with representatives from two of the businesses. During the discussion on the Blade Sign Program, the businesses asked if the amount of funds available for each individual business could be increased.

## **Background**

The Blade Sign Program is part of the beautification efforts throughout the Canby Urban Renewal District. The Blade Sign Program partners with property owners and businesses to add a unique and attractive design feature to their buildings.

The program was created to enhance the vibrant and interesting business district for visitors and residents. The program provides up to \$200 for sign hardware, mounting materials, and installation. Blade signs need to have a maximum sign face area of 20 square feet; a clearance of 8 feet, extend no more than 8 feet from the building, and, be located 2 feet away from the curb.

## **Discussion**

City staff will present a brief overview of the Canby Blade Sign Program. The discussion will explore whether or not to expand the funding available to businesses who utilize the Blade Sign Program.

# Canby Blade Sign Program

Funding for hardware and mounting materials to beautify your commercial building



The Canby Urban Renewal Agency supports local businesses with resources to help them succeed. The Blade Sign Program partners with property owners and businesses to add a unique and attractive design feature to their buildings and create a vibrant and interesting business district for visitors and residents. Eligible businesses must be located within the blue boundary to the right and have a building permit for erecting blade signs.

## The Blade Sign Program offers:

- Grants of up to \$200 to purchase hardware, mounting materials, and install the blade sign.
- Assistance in choosing blade sign hardware that complements the building style and business type, connections to local artists to create original, eye-catching blade sign designs and options for blade sign installation.

## Eligible projects include:

- Buildings within the Urban Renewal District
- Blade signs attached to the building or hanging from the awning
- Blade signs that: have a maximum sign face area of 20 square feet; a clearance of 8 feet, extend no more than 8 feet from the building and are 2 feet away from the curb
- One sign per building frontage for each business license issued

## Ineligible projects:

- Projects for businesses not in the Urban Renewal District
- Blade signs that project over the roof line or top of the parapet wall, whichever is higher

<u>Special consideration for signs that are:</u>

- Downtown area businesses
- Unique designs that add artistic flair and character to Canby's business districts
- Signs created by local artists
- Signs that use higher end materials and construction techniques

## Ineligible participants:

• Properties for residential use, unless it is a mixed use development

Note: The sign is revocable at any time if it is determined to be in the public interest when located within the public right of way.
