Summary

Adoption of Budget Appropriation Transfer Resolution for the 2021-2022 fiscal year.

Background

To maintain compliance with local budget law, an appropriation transfer resolution must be adopted to allow for the increase and decrease in expenditure appropriations between departments.

Discussion

General Fund

In the FY2022 adopted budget the Court department had total expenditures of \$521,774, while the Finance Department had total expenditures of \$632,756. In Resolution 1351 these amounts were transposed. This supplemental budget adjustment corrects the transposition.

Fiscal Impact

None, spending authority is being transferred between appropriations with no increase to total appropriations.

Options

- 1. Approve the budget appropriation transfers and allow City operations to continue seamlessly as well as stay in compliance with Oregon Budget Law.
- 2. Do not approve the budget appropriation transfers resulting in significant constraints on service to the community; as well as creating a situation where we would be breaking Oregon budget law and subject to an audit finding.

Summary

Adopting Resolution UR-22-003 of the Canby Urban Renewal Agency Adopting the Annual Budget, Making Appropriations, and Imposing and Categorizing Taxes for the Fiscal Year 2023.

Background

Oregon budget law requires adoption of an annual budget by June 30 of each year. ORS 294.453 requires the City to hold a public hearing, and ORS 294.458 requires the City to submit tax certification documents to the County Assessor by July 15th.

Discussion

On June 15, 2022 the URA Budget Committee met to deliberate over the FY2023 budget. Staff reviewed the proposed budget with the Committee and allowed for public comment. The Proposed Budget was approved by the Committee with no changes.

Fiscal Impact

The ability to pay debt, proceed with capital projects already in process and run the general operations of the Urban Renewal Agency.

Options

- 1. Approve the resolution and allow staff to pay on outstanding debt and keep the URA functioning.
- 2. Do not approve the resolution and risk defaulting on outstanding debt, contracts, and commitments to the community. This could also result in Material Audit findings.

Recommendation

Staff recommends the Commission approve URR 22-003.

Summary

The City of Canby's Economic Development staff received an application for a Façade Improvement Program grant for Dewar Chiropractic, 332 NW 1st Avenue, for up to \$25,000. The applicant intends to update the rear façade of the property – which is visible from NW 2nd Avenue. The application requests funding for prepping, painting, labor, and materials as outlined below:

- Lightly pressure wash two exterior walls as needed
- Scrape and grind down areas as needed
- Apply skim coat as needed to smooth out surface to best of ability.
- Apply Primer
- Apply LOXON* Self Cleaning exterior Paint- Clean up
- Labor and materials
- Remove Gutters as needed and install new Fascia

*LOXON Self-Cleaning paint is a Sherwin Williams product designed to stay clean and weather well, with long term, minimal maintenance.

Background

Since 2010, The Canby Urban Renewal Agency has funded construction grants of up to \$25,000 to encourage private investment within Canby's Urban Renewal District. The Façade Improvement Program partners with property owners and businesses to make improvements to the exterior of buildings clearly visible from the street. This partnership helps the Canby Business District revitalize and become more inviting to tenants, customers, and residents. This program has been successful in generating design improvements at approximately 3 properties per year in downtown Canby and along HWY 99E.

Discussion

Dewar Chiropractic is located in downtown Canby at 332 NW 2nd Avenue. Dewar Chiropractic is unique in the sense that both the front and the back of the building facades can be seen from the street. This application is for the side of the building that can be seen from NW 2nd Avenue (which is the back of the building).

The application is sent to the Main Street Design Committee for comments. Comments received:

• "I agree with this request to improve the appearance & to upgrade the exterior walls as mentioned in this proposal. Am looking forward to the application."

 - As follow up, staff provided the applicant with the website to the <u>Sherwin Williams' historic color palette</u>. Applicants are not required to utilize the color schemes and are permitted to utilizing paint from the paint manufacturer of their choice.
